

The Office of the Seniors Advocate

- B.C. government introduced legislation outlining duties and authorities of Seniors Advocate in February 2013
- Seniors Advocate Act passed on March 14, 2013
- Isobel Mackenzie appointed as B.C.'s first Seniors Advocate as of March 31, 2014





Role and Responsibilities

- Monitors the provision of seniors' services
- Analyzes issues pertaining to seniors
- Provides information and referral to seniors and their family members
- Reports to Minister and to the public on issues affecting seniors

5 mandated areas:

- Health care
- Housing
- Income support
- Personal Support
- Transportation



B.C.'s Seniors - Demographics

- 820,000 seniors in B.C. (17% of population)
- Projected to grow to 1.35 million, or 24%, by 2031
 - 56% (459,000) age 65-74
 - 30% (246,000) age 75-84
 - 14% (115,000) age 85+
- According to the 2011 Census, 7.66% of B.C. seniors cannot hold a conversation in English
 - For B.C. seniors 75+ this increases to 9.22%





B.C.'s Seniors: Housing and Income

- Less than 4% of live in residential care
 - 1.7% of 65-84 year olds
 - 15% of 85+ year olds
 - Less than 4% live in Seniors
 Housing
- Less than 4% receive home support
 - 2.3% of 65-84 year olds
 - 12.5% of 85+ year olds



- 20% rent
- 80% own their home
 - 78% have no mortgage
- Nearly 2/3 live in urban areas
- 26% live alone
- Median income is \$24,600
- 52,000 earn \$16,200 or less
- 11% are employed



Housing


- Seniors' Housing in B.C., Affordable,
 Appropriate, Available
 - More help for low-income renters through increases to SAFER
 - New Homeowner Expense Deferral Account program
 - Fundamental redesign of registered assisted living
 - Ensure quicker access to preferred residential care bed
 - All residential care rooms are single room occupancy with ensuite bath by 2025





Lack of Awareness

- Do seniors know about programs that can help them?
 - Senior homeowners with household incomes less than \$30,000 are least likely to be aware of Provincial Property Tax Deferment Program (PTD)
 - only 40% of these homeowners were aware of the program
 - Only 39% of low income seniors knew about MSP
 Premium Assistance program
 - Only 31% of respondents knew about Provincial
 Home Adaptations for Independence Program
 - Only around 50% of seniors knew about the SAFER program






Challenges in Residential Care

 Studied health data for all home support and residential care clients in B.C.

• Found:

- Overuse of some medications
- Up to 15% of seniors in residential care who may be able to live more independently
- B.C. lagging in physical therapy and recreational therapy

Incidence of psychiatric disorders and mood disorders with medication prescriptions, B.C. residential care population





Senior received any occupational therapy in last 7 days	8.9%	22.2%	1.8%
Senior received any speech-language therapy in last 7 days	0.2%	0.6%	0.4%
Senior received any recreational therapy in last 7 days	21.8%	42.3%	6.8%



Caregiver Distress


Caregivers in Distress, More Respite Needed

- Findings:
 - 29% of caregivers are in distress, one of the highest rates in Canada
 - Increases to 38% for those caring for seniors with complex care needs
 - Strongest predictor of distress is number of hours a caregiver provides
 - Unpaid caregivers provide an average of 19 hrs/week, increases to 30 hr/week for caregivers in distress
 - Three provincial respite programs
 - Adult Day Programs (ADP)
 - Respite Beds
 - Home Support
